Government workers' group files raps vs Mikey over SALN

MANILA – The militant government workers organization Courage on September 10 filed graft charges against Pampanga Rep. Juan Miguel “Mikey” Arroyo before the Ombudsman urging an investigation into his alleged unexplained wealth. In a six-page complaint, Cour-

age asked the Ombudsman to probe the presidential son's failure to declare the P6 City, California in his Statements of Assets and Liabilities and Net Worth (SALNs).

The group cited news reports in calling for the Ombudsman to investigate how Arroyo's net worth increased from P76.9 million in 2005 to P99.2 million in 2008.

Courage noted a media interview where Arroyo was quoted as saying that his money came from wedding gifts and campaign contributions from the last elections.

Courage president Ferdinand Gaité claimed Arroyo violated Republic Act 6713, or The Code of Conduct and Ethical Standards for Public Officials and Employees.

Gaité said Arroyo is mandated under the law to “lead a modest life appropriate to his position and income” and is not supposed to “indulge in extravagant or ostentatious display of wealth in any form.”

He said Arroyo, as a public official, also has the obligation to submit his SALN declarations under oath reflecting all his assets, liabilities, net worth and financial and business interests, including those of their spouses and unmarried children less than 18 years of age living in their households.

Gaité also claimed Arroyo violated the Omnibus Election Code which prohibits the acceptance of electoral contributions.

Gaité said Arroyo failed to declare and submit before the Commission on Elections (Comelec) a detailed statement of his campaign contributions and expenditures 30 days after election as mandated by law.

Assistant Ombudsman Jose de Jesus Jr. said the complaint would be evaluated to find if sufficient basis exists to warrant an investigation.

De Jesus, however, pointed out the Office of the Ombudsman does not have the authority to suspend a lawmaker pending investigation of the charges.

De Jesus explained the power to suspend a legislator belongs to Congress or the legislative branch of the government. ■
