Lacson: Estrada, Palace want me in jail

MANILA – Citing "Operation Delta," Sen. Panfilo Lacson Tuesday asserted that former President Joseph Estrada had the "motive" to order the killing of publicist Salvador "Bubby" Dacer and his driver Emmanuel Corbito in 2000.

In a privilege speech titled "Prosecution or Persecution," Lacson maintained his innocence even as he pointed to

Malacañang as the unseen hand that was orchestrating the alleged fabrication of testimonies in a desperate effort to put him behind bars.

"This administration and its cohorts will stop at nothing to deliver misery at my front door," he said.

"Scheming minions" Behind it all are scheming minions of the Gloria Macapagal-Arroyo administration and lately joined by the very same person who, along with this

representation and four or five other personalities, were named by former Police Senior Supt. Cezar Mancao in his open court testimony last Sept. 3, 2009," he added.

Lacson identified the person as former President Joseph Ejercito-Estrada.

"In his informal talks with some of our common friends, he would maliciously alibi with feigned ignorance ask, 'What makes Ping angry with Dacer,' or 'Why is Ping mad at Bubby Dacer?'" Lacson said.

"He should ask himself these questions and I'm sure he knows the answers to them," the senator said.

Lacson blasted Estrada for the "temerity" to issue a press statement attributing to him the supervision of "Operation Delta," which Mancao had said was designed to "neutralize Dacer."

Lacson said he knew nothing about the operation and learned about it through recent newspaper reports.

Following the arrest and extradition of Mancao and Glen Dumlao, the media have been following this story like a tele-novela, according to Lacson.

Dumlao's affidavit

Former police officers Mancao, Dumlao and Michael Ray Aquino had worked with Lacson while he was head of the now defunct Presidential Anti-Organized Crime Task Force (PA-OCTF) and later on as chief of the Philippine National Police.

Why Mancao (now a state witness) had decided to sign his Feb. 14, 2009, affidavit – in which he overheard Lacson and Aquino allegedly talking about the plan to kill Dacer – "is a matter between him and God," Lacson said.

In Mancao's court testimony and Dumlao's sworn affidavit, the two narrated that in the early part of October 2000, they went to the office of then Senior Superintendent Aquino to ask him what the so-called "Operation Delta" was all about.

Lacson then lifted excerpts from that supposed conversation as narrated by Dumlao in his first and handwritten sworn affidavit.

"When we reached the office of Police Superintendent Aquino, Police Superintendent Mancao asked: 'Noy, what is this special operation?' Police Superintendent Aquino answered: 'It's for
