HEARTY BEEF ASADO

Indispensable in the preparation of Hearty Filipino meals and dishes

- Datu Puti or UFC Vinegar
- Datu Puti or UFC Nelicom Fish Sauce
- UFC Tomato Sauce
- Datu Puti or UFC or Soy Sauce

INGREDIENTS

- 1/2 cup Golden Fiesta Cooking Oil
- 50g annatto seeds
- 1 1/2 kilos beef short plate
- 1/2 tsp black pepper
- 1/2 tsp salt
- 18 g garlic
- 4 pcs bay leaf
- 1/4 cup rice wine

- 1 1/2 tsp whole peppercorns
- 1/4 cup Datu Puti or UFC Vinegar
- 1/4 cup Datu Puti or UFC or Nelicom Fish Sauce
- 117 g onion, diced
- 2 tbsp UFC Tomato Sauce
- 1 tbsp Datu Puti or UFC Soy Sauce
- 8 cups beef stock
- 4 tbsp flour

PROCEDURE

1. Mix annatto seeds and half the cooking oil in a pan. Cook until color is extracted. Strain out seeds and set aside.
2. Season meat with salt and pepper. Fry and Brown meat in remaining oil. Add garlic, bay leaf, rice wine, vinegar, fish sauce, and pepper. Then add onion, tomato sauce, and soy sauce. Fill pot with stock. Simmer or pressure cook until tender.
3. Place the annatto oil over medium heat. Add the flour and cook into a paste. Add the flour paste to the beef with stock to thicken sauce. Slice beef and serve sauce over beef.
